**Further, would like to update you with the latest status of the JRPICL with respect to NCDs issuance vide Debenture Trust Deed dated 04<sup>th</sup> May, 2017. In furtherance to the meeting of Debenture Holders held on 16<sup>th</sup> March, 2023 and therein JRPICL had informed of filing a writ petition for release of annuities against the Jharkhand Government. However, the same was withdrawn post release of certain annuities.**

**Furthermore, as you are aware that the company JRPICL has once again filed Writ Petition bearing No. 3029 of 2024 before High Court of Jharkhand at Ranchi for release of annuities on 14.05.2024 and the same was last listed on 02.02.2026 and the same was not reached for hearing on the said date matter will be listed on 25.02.2026 for further hearing.
