#### **Detailed Rationale**

Infomerics has downgraded the ratings and moved to "Issuer Not Co-Operating" category for Non-convertible Debentures (NCDs) and Proposed Non-Convertible Debentures of Achiievers Finance India Private Limited reflecting lack of adequate information available about the performance of the company and the uncertainty around its credit risk. Infomerics assesses whether the information available about the entity is commensurate with its rating and reviews the same as per its policy. The lenders, investors and other market participants are thus

advised to exercise appropriate caution while using this rating as the rating may not adequately reflect the credit risk profile of the entity, despite the rating revision.

#### Non-cooperation by Issuer

Infomerics has been regularly following up with the company to provide the required data to monitor its assigned rating to the Non-Convertible Debentures (NCDs) and Proposed Non-convertible Debentures (NCDs), vide mail communications dated November 04, 2024, November 05, 2024, November 06, 2024, and November 07, 2024, and concurrently over phone calls. However, despite repeated requests by Infomerics, the company's management has not submitted the requested information for monitoring the ratings. Availability of information is very critical in rating exercise. In the absence of the requisite information, in consonance with SEBI guidelines, Infomerics has to review the ratings based on the best available information.

Accordingly, the long-term rating of the Non-Convertible Debentures (NCDs) and Proposed NCDs facilities aggregating to Rs. 25.00 crore of Achiievers Finance India Private Limited shall be moved under the 'ISSUER NOT COOPERATING' category by Infomerics and the ratings will be at 'IVR BB/ Negative; ISSUER NOT COOPERATING' based on best available information. Accordingly, the lenders, investors and other users of this rating are requested to exercise adequate caution while using this rating as this rating may not adequately reflect the current credit risk profile of the company.
