# Ratings:Reaffirmed

**Nature of Non-co-operation:** The rating was due for review in February 2018. BWR took up with the issuer to provide required information over emails and through telephonic communications. Despite the best efforts of BWR to get at least the minimum required information for a review, the company has continued to remain non cooperative. The Company has not provided the minimum required information for a review in spite of repeated followup via emails and telephonic calls.

**Limitations of the rating:** Information availability risk is a key factor in the assessment of credit risk as generally, noncooperation by the rated entities to provide required information for a review of the assigned rating may also be accompanied by financial stress.

## **About the Company (Information as available)**

Blue Blends India Limited was incorporated in 1981 as a private limited company and became a public limited company in 1983. The Company came out with a public issue in February 1984 and its equity shares are listed in BSE. The Company manufactures various denim fabrics with varying degrees of characteristics. The Company is promoted by Mr. Anand Arya.
